Applications for 2016-17 school transportation for pupils residing in the Brighton Central School District who attend private and parochial schools must be filed on or before **April 1, 2016** (except where a family moves into the district after **April 1, 2016** in which case application must be made within 30 days after establishing residence in the District). Brighton Central School District transportation policy provides transportation for pupils in grades K-6 who live more than 1/4 mile from school and grades 7-12 who live more than 3/4 miles from school. There is a 15-mile maximum for students attending private and parochial schools. Transportation is provided on an equal basis to pupils in the public schools and those attending private and parochial schools. **It should be noted that even though a pupil is now being transported by the District, a new application must be submitted if transportation is again desired for the following school year. Forms must be submitted to the Transportation Department before service can be provided.** It is critical that we be notified of any change of busing by filling out the transportation form.

ANY FORMS NOT RECEIVED BY APRIL 1, 2016 WILL NOT BE PROCESSED UNTIL AFTER THE START OF THE SCHOOL YEAR, AND TRANSPORTATION WILL BE PROVIDED ONLY IF IT'S AT NO ADDITIONAL COST TO THE DISTRICT!
